REQUIREMENTS:

- There are no entry fees.
- The nomination form must be fully completed.
- A nomination letter, not exceeding two 8 1/2 x 11” pages, must be submitted with this form and must include the following:
 - Qualifications in detail for the designated category
 - Achievements in other areas
- More than one nomination may be made for an individual or group.
- Nominees need not be members of the nominating organization or group.
- Previous Headliners are ineligible.
- *Honorees must be able to attend the 30th Annual AWCSA Awards Banquet and Silent Auction on Friday, June 18, 2010, at the Westin Riverwalk San Antonio Hotel.*
- **THE NOMINATION DEADLINE IS FRIDAY, March 26, 2010.**

CATEGORIES:

- **Professional Achievement:** Nominee must have been an active 10-year member in a profession or industry and must have made a significant contribution to his or her field. Community involvement will be an additional consideration.
- **Volunteer Service:** Nominee must have been active for at least 10 years in any type of volunteer service and must have made a significant contribution to advance the organization’s goals.
- **Public Endeavor:** Nominee must have been active for at least 10 years in an area of civic action that impacts the community such as government, health, welfare or environment. Nomination may have worked full-time, part-time or on a volunteer basis.
- **Education:** Nominee must have been active for at least 10 years in the field of education and must be recognized for outstanding achievement in a particular field of specialization.

JUDGING:

The San Antonio Professional Chapter of the Association for Women in Communications, Inc., reserves the right to transfer nominees between categories as appropriate, to withhold an award in any category that does not receive suitable nominations, and to add additional awards as deemed by the Headliner Committee. Honorees will be notified by telephone and e-mail.
